ORDER

1. The Regulations for UG Programmes under Choice Based Credit & Semester System (CBCSS-OBE) in Affiliated colleges were implemented in the University w.e.f 2019 admission as per paper read as (1) above.
2. As per the Clause 3.8 of the Regulations for UG Programmes under CBCSS-OBE, implemented w.e.f 2019 admission, *the maximum age limit for admission to UG Programmes shall be 23 years as on 1st June of the academic year. For SC/ST candidates the age limit is 25 years as on 1st June of the academic year.*
3. Meanwhile, a few requests of over aged candidates for admission to regular UG Programme in affiliated colleges under the University were placed before the Academic Council for consideration, as per paper read (2).
4. Subsequently, the special meeting of Academic Council (XXI meeting), as per paper read (3) above, resolved to remove the Age limit specified for admission to the UG programmes w.e.f 2022-23 admission (Clause- 3.8 of the Regulations for UG Programmes under CBCSS-OBE, implemented w.e.f 2019 admission).
5. Considering the matter in detail, the Vice Chancellor accorded sanction to remove the maximum age limit prescribed in Clause 3.8 of the Regulations for UG Programmes under CBCSS- OBE, for admission to UG Programmes w.e.f 2022-23 admission.
6. The Clause 3.8 of the Regulations for UG Programmes under CBCSS-OBE, implemented w.e.f 2019 admission is modified accordingly.
7. The U.O read as paper (1) above stands modified to this extent.
8. Orders are issued accordingly.
