ORDER

1. As per the Guidelines for University Junior Research Fellowship, "The candidates who were already registered for PhD Programme in any of the University Departments or University recognized Research centres under Kannur University and who are qualified in the test conducted by the University for the purpose shall be eligible for the award of Junior Research Fellowship, subject to the conditions as may be determined by the Syndicate".

2. As per the reference read (1) above, the Syndicate has recommended that the Research Fellowship of the University JRF will be entitled to all Full Time Scholars, provided that they are not receiving any

financial aid from any other agency.

3. Vide the reference read (2) and (3) above, 73 full time research scholars had been awarded the University Junior Research Fellowship @ Rs.5000/- (Rupees Five thousand only) per month for a period of 3 years, to give the 1st tenure of the fellowship for the coursework period of six months and the remaining tenure of the fellowship may be reckoned from the date of joining at the research centre based on the formal registration order from the University.

4. Vide the reference read (4) above, the scholars who have completed coursework were permitted to attend the concerned research centres from the very next day of completion of coursework and thus from 2014-15 batch coursework onwards there is no gap of time period for the scholars between the completion of

coursework and the date of joining at the research centre.

5. Out of the above 73 Research Scholars availing Junior Research Fellowship, 23 Research scholars have now become ineligible for the award of Junior Research Fellowship (as the tenure expired/converted to part time/selected by other funding agencies/discontinued/submitted the final thesis/Bill and Progress report has not been submitted within the prescribed time) and they are excluded from the list of awardees as per the orders of the Vice-Chancellor.

6. As per the reference read as (5) above, new applications from 41 (Forty one) Full Time Research Scholars have been received to consider them for University Junior Research Fellowship. Therefore, a total of

91 full time research scholars are eligible for University Junior Research fellowship as detailed below

- 7. The Vice-Chancellor, after considering the matter in detail, has accorded sanction to award the University Junior Research Fellowship @ Rs.5,000/- per month to the scholars mentioned at para 6 above.
 - 8. The following orders are therefore issued on the matter:
 - i. The University JRF in respect of 23 research scholars who are ineligible due to various reasons as mentioned at para 6 is cancelled.
 - ii. The tenure of University Junior Research Fellowship is 3 (three) years and the amount per month is Rs.5000/- (Rupees Five thousand only). For those scholars who have done the coursework, the first tenure of the fellowship may be released from the date of joining to coursework based on the certificate issued by the coursework co-ordinator. The remaining tenure of the fellowship will be reckoned from the date of joining at the research centre after the completion of coursework.
 - iii. The Fellowship will be awarded subject to availability of funds in the University.

The scholars should furnish their employment status once in six months.

The Research Fellows are not permitted to accept any assignment, paid or unpaid, during the tenure of award of University Junior Research Fellowship. A certificate from the Research iv. Guide, countersigned by the Head of the Research Centre, to the effect that the Research v. Scholar is not availing any other financial assistance, shall be submitted, each time when the candidate applies for University Fellowship.

Only Full-Time Research Scholars and whose research works are regularly monitored by Research Guide concerned are eligible for University JRF. In case the Research Guides are not available for regular monitoring of research work of a Research Fellow, the Head of the vi. Research Centre will intimate the status for taking a decision in the award of JRF further. The

decision of the University in this regard will be final. The Progress Report of Research Work in the prescribed format shall be enclosed with the vii.

The Research Fellows are entitled for a maximum period of 15 (Fifteen) days leave in a viii.

The Research Fellows should enclose detailed Attendance Certificate showing the actual days spent by them at the Research Centre [Both in the Calendar Year & the particular month (s)], authenticated by the Research Guide and Head of the Research Centre concerned, each time ix.

The Research Fellows who are availing leave for data collection and other outstation research activities shall obtain prior permission from the Head of the Research Centre through the Research Guide. An attested copy of the request approved by the Research Guide, shall be X. forwarded to the University by the Head of the Research Centre, along with the application for Junior Research Fellowship. If the duty leave availed by a Research Fellow is more than the days attended at the Research Centre, a clarification letter from the Research Guide, approved by the Head of the Research Centre, shall be enclosed separately.

The Fellowship now ordered shall be terminated at any time during the tenure and the xi.

decision of the University will be final and binding in this regard.

The research fellows shall submit every month their attendance report, properly countersigned by the research guide and head of the research centre with an undertaking of non employment. xii.

- The fellowship granted shall be cancelled, on misconduct of the Research Fellow, unsatisfactory Progress Report of Research, lack of regular supervision of research work by Research Guide concerned and ineligibility of the Research Fellow for the award of JRF, if xiii.
- The expenditure towards the award of fellowship will be met from the Head of Account 'MH-329-264' of the current year's budget estimates. xiv.
- The University Order read (3) above stands modified to this extent. XV.
