

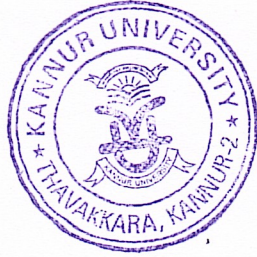

Conditions:

1. The rate quoted should be inclusive of GST and all other charges, if any. The base rate, GST charges and other charges if any should be furnished separately and nothing extra shall be admissible over and above the rate quoted.
2. The Contractor shall arrange all material & equipment and should be got approved by the Registrar through the Assistant Engineer (Electrical) and work shall be executed as per KPWD specifications.
3. Payment will be made through bank account and no advance payment will be sanctioned.
4. Work shall be completed within 30 days from the date of Agreement.
5. The Defect Liability Period shall be 18 months (special repairs) from the date of satisfactory completion of the work and the Contractor shall be responsible to maintain all his works till completion of the Defects Liability period and to hand over the work to Registrar Kannur University.
6. 3% of the Contract value has to be remitted before executing the agreement towards Performance Guarantee which will be repayable after the completion of defect liability period on the request of the Contractor.
