- 1. University orders were issued vide papers read (1) granting extension of time up to 31.12.2020 for all Ph.D. / M. Phil scholars for submission of final Thesis / Dissertation whose date of submission of Ph.D. thesis / M.Phil Dissertation expired / is due to expire on or before 31.12.2020 during the Covid-19 pandemic period.
- 2. The meeting of the Standing committee of the Syndicate on Course, Research, Library and Publication held on 25.11.2020 recommended vide paper read (2) to grant extension up to 31st March 2021 to all the Research Scholars for the submission of final Ph.D. thesis in the backdrop of Covid-19 pandemic situation.
- 3. The Secretary, UGC, vide paper read (3) above, issued public notice wherein it is stated that due to the Covid-19 pandemic, in the larger interest of the research scholars, a further extension of six months for terminal M.Phil / Ph.D. students who were supposed to submit their thesis by 31st December 2020, may be granted by the Universities, i.e., till 30th June 2021.
- 4. Syndicate of the University, while considering the recommendations of the Standing Committee on CRLP and the public notice issued by UGC, resolved vide paper read (4), to grant extension to all research scholars for the submission of final thesis upto 30th June 2021 in the backdrop of Covid-19 pandemic situation.
- 5. The resolution of the Syndicate has been implemented by the Director, Research Directorate as per the powers vested on him vide paper read (5) and the following orders are issued.

"Extension of time upto 30.06.2021 is granted to all Research Scholars for the submission of final thesis in the backdrop of Covid-19 pandemic situation".
