ORDER

- 1.Vide paper read 1st above, the rent fixed for Cafeteria by the Engineering wing as per PWD norms is Rs.43,000/-+GST and the Syndicate has resolved to fix the rent for Cafeteria as Rs.43,000/-+GST vide paper read 2nd above.
- 2.Quotations were invited in response to vide paper read 3rd above for starting Cafeteria a Student Amenity Centre, Thavakkara Campus.
- 3.As no quotations were received in response to the quotation notice read 3rd above, a discussion was held vide paper read as 4th above, regarding the revision of the rent fixed for Cafeteria and it was recommended to revise the rent fixed for Cafeteria by the Engineering Wing, at par with market rate.
- 4.The Vice chancellor has ordered to place the above said matter along with the rent amount recommended by the Engineering wing at par with market rate ie, Rs.20,000/-+ GST per month before the Syndicate.
- 5. As the Syndicate resolution vide paper read 6th above is silent about the rent amount, the Vice-Chancellor has ordered to resubmit the matter of fixing the rent of Cafeteria at Student Amenity Centre before the Syndicate for consideration vide paper read as 7th above.
- 6.Vide paper read 8th above the syndicate deferred for detailed study the matter of fixing the rent of Cafeteria, at Student Amenity Centre, Thavakkara Campus by the Standing Committee of the Syndicate on General Affairs &Staff and Finance.
- 7.Vide paper (U.O) read as 9th above, the rent for using facilities at Cafeteria, Student Amenity Centre, Thavakkara fixed as Rs.2000/- +GST
- 8.Vide paper read 10th above, Syndicate has resolved that Cafeteria (Room No.2) in Student Amenity Centre be used only for dining purpose observing green protocol for the official functions of University or functions organised by University Students and staff, free of cost. Also resolved to fix usage fee of ₹5000/- (Rupees Five Thousand only) per day for public. The Syndicate resolution was implemented by the Registrar.

- 9.Therefore, the Cafeteria (Room No.2) in Student Amenity Centre be used only for dining purpose observing green protocol
- a) for the official functions of University or functions organised by University Students and staff, free of cost.
- b) by public, remitting usage fee of ₹.5000/- (Rupees Five Thousand only) +GST per day.
