## ORDER

- 1. As per the paper read (1) above, the Regulation for PG Programmes under Credit Based Semester System (CBSS) in Affiliated Colleges were implemented in the University w.e.f 2014 admission and certain modifications were effected to the same later vide paper read (2).
- 2. As the regulation of UG & PG programmes implemented in the University in Affiliated colleges, w.e.f 2014 admission is silent with respect to the guidelines to be followed for the preparation of position list, a subcommittee of the syndicate was constituted vide paper (3) above to frame the Rules/Guidelines for the preparation of position list
- 3. Subsequently the Rules/Guidelines for preparation of position list for UG & PG programmes were framed by the Subcommittee constituted for the same and as per the recommendation of the subcommittee, Clause 23.2 of PG Regulation 2014 is modified as "position certificate upto ten (10) positions (i.e, I to X positions) shall be issued to the students, PG programmes under CBSS of Affiliated Colleges w.e.f 2014 admission on the basis of highest marks secured for the programme. In case of a tie, highest of OGPA is to be considered" and a U.O.in this regard has issued vide Paper read 5 above.
- 5. As per the paper read (6) above the meeting of the syndicate held on 04.07.2023, resolved to amend clause 23.2 of PG Regulations" Position Certificate up to 10th position will be issued on the basis of highest OGPA secured for the programme" be modified as "Rank certificates up to third rank shall be issued, instead of Position Certificate, to the PG students of Affiliated Colleges and University Departments/Centers w.e.f 2021 admission onwards on the basis of highest OGPA secured for the programme", The Syndicate resolution has been implemented and the Examination branch vide Paper read (7) above has forwarded the resolution of the Syndicate for amending clause 23.2 of the PG regulation to the Academic branch.
- 6. The Vice Chancellor after considering the matter in detail and in exercise of the powers of Academic Council conferred under section 11 (1) of Kannur University Act 1996 and all other enabling provisions read together with, accorded sanction to modify Clause 23.2 in the regulation for PG programmes in Affiliated Colleges w.e.f 2021 admission , as recommended by the Syndicate, subject to reporting to the Academic Council as follows
- "Rank certificate up to third rank shall be issued instead of Position certificate, to the PG students of Affiliated Colleges with effect from 2021 admission onwards on the basis of highest OGPA secured for the programme"
- 7. The U.O s read vide papers 1,2 & 5 stand modified to this extent
- 8. Orders are issued accordingly.
