## ORDER

1. As per paper read (1) above the Scheme, Syllabus and Pattern of Question paper of Core, General Awareness and Generic Elective Courses of the BSc Food Technology programme (LRP) under Choice Based Credit and Semester System (OBE) was implemented in Affiliated Colleges w. e.f. 2022 admission and certain modifications were effected thereafter vide paper read (2).

2.According to the Syllabus of the B.Sc.Food Technology programme implemented vide papers read as (1) & (2) above, Physics and Chemistry were the Complementary Courses.

3. Considering the request of the Principal, Sir Syed Institute of Technology, Karimbam, Taliparamba, to change the Complementary course of B Sc Food Technology in the College from Physics to 'Biotechnology', the opinion of the former Chairperson Board of studies, Biotechnology was sought vide paper read 4 above, in the circumstance of non-existence of the Board of Studies at that time.

4. Subsequently, the former Chairperson, BoS (Board of Studies), Biotechnology vide paper read (5) above remarked that there is nothing wrong in offering Biotechnology as a Complementary subject for the B.Sc. Food Technology and suggested to permit to offer Biotechnology as a complementary subject instead of Physics for the BSc Food Technology programme. The Remarks furnished by the former Chairman was approved by the Vice Chancellor in exercise of the powers of the Academic Council conferred under the Section 11(1) of Chapter 3 of Kannur University Act, 1996.

5.Subsequently, the Complementary Course of B.Sc. Food Technology programme was changed vide the U.O. read as paper (6) above.

6.Therefore, Biotechnology is introduced as the Complementary Course of the B.Sc. Food Technology programme along with Physics & Chemistry with effect from 2023-24 academic year, subject to reporting to the Academic Council. Orders are issued accordingly.
