## **ORDER**

- 1. As per paper read (1) above, one last chance was granted for Re-Registration (applicable to all Semesters) for candidates of B.Tech. 2012 and earlier admission (Regular), 2011 & earlier admission (for Part Time), after levying a Re-Registration fee of Rs.5000/- (Rupees Five Thousand only) and Rs. 500/- per paper (Rupees Five Hundred only) and to conduct Supplementary Examination for eligible candidates of 2013 admission onwards (Regular) and 2012 admission onwards, for the Part Time candidates.
- 2. Meanwhile,the Examination Branch, as per paper read (2) requested to consider the matter of granting one time Mercy chance for all Semesters, for the candidates of 2011 to 2013 admission, along with the Supplementary Examinations for S1& S2 combined (January 2021), S3(October 2020) S4 (May 2021), S5(November 2020), S6 (May 2021), S7( November 2020) and S8 (April 2021) which will be the last Supplementary examination to be conducted by this University for the B.Tech. candidates.
- 3. Considering that the matter is related to relaxation of Regulations beyond the stipulated duration for completion of the course, the matter was placed before the Academic Council, as per paper read (3).
- 4. Meanwhile, Examination Monitoring Committee recommended to grant one time Mercy chance in all Semesters, for candidates of 2011 to 2013 admission and to conduct examinations just after the completion of 8th Semester Supplementary exam of 2014-18 batch as per paper read (4).
- 5. Subsequently, as per paper read (5), the meeting of the Syndicate held on 15.11.2021, vide item No. 2021.752, resolved to approve the Minutes of the meeting of the Examination Monitoring Committee held on 10/11/2021. Further resolved to collect Re-registration charges as Rs.5,000/- (Rupees Five Thousand only) and Rs.500/- for each paper from the candidates appearing for one time final Mercy chance examination for 2011 to 2013 admission B.Tech. programme.

- 6. As the 8th Semester Supplementary examinations(April 2020) for 2014-18 batch will be completed on 17.12.2021, the Examination Branch as per paper read (6), requested to take urgent action on the recommendations of the Examination Monitoring Committee, as approved by the Syndicate.
- 7. The Vice Chancellor, after considering the matter in detail and in exercise of the powers of the Academic Council conferred under Section 11(1) Chapter III of Kannur University Act 1996, issued the following orders, subject to ratification by the Academic Council.

(i)Permission is granted for one time final Mercy chance, to candidates of 2011 to 2013 admission, for all semesters of B.Tech. Examinations, after levying a Re-Registration fee of Rs.5000/- (Rupees Five Thousand only) and Rs. 500/- (Rupees Five Hundred only) for each paper.

- (ii) The aforesaid one time final Mercy chance examinations shall be conducted just after the completion of 8<sup>th</sup> Semester Supplementary Examination of 2014-18 batch (April 2020).
- 8. The U. O read (1) above stands modified to this extent.
