ORDER

1. The Regulations for Five Year Integrated Master's Programme (FYIMP) in the University Teaching Departments/ Schools were approved and implemented in University Teaching Departments w. e. f. the academic year 2024- 25, as per the paper read (1) above and certain modifications were effected to the same vide paper read (2) .

2. As per paper read (3) above, the FYIMP Implementation Committee was reconstituted.

3. As per paper read (4) above, the meeting of the FYIMP Implementation Committee held on 31/07/2025 took the following decisions regarding the course registration and additional course consideration:

i. *As per the regulations clause (11.3 and 11.5) students need to register and finalise the courses selection for each semester. Except from foundation courses which are from common basket at 100 level courses; and for single major pathway where students selected all courses (intermediate and higher level (from the respective department itself, students opting major and minor from other departments (from semester 3 onwards) shall register for the respective course chosen from other departments with course fee for the selected courses.*

ii. *Course fee for separate courses may be determined by the semester fee divided by number of courses offered in the semester. Such students shall register and pay fees for the number of courses opted from the parent department and for the number of courses opted from other departments.*

iii. *This will also be applicable for additional courses opted by the student who would prefer to have additional minor or double major beyond the stipulated minimum credit requirement.*

iv. *As per regulations of FYIMP, student shall complete course registration within two weeks of the commencement of the semester (Clause 11.3). And as per clause 11.5, student can opt out of a course or courses registered within thirty days from the commencement of the semester.*

v. *Therefore, student course registration with course fee can be completed within one month of the commencement of the semester from semester 3 onwards*

- 4.The Vice Chancellor ,considering the matter in detail, has ordered to place the matter fixing course fee before the Syndicate for consideration .
5. The Syndicate at its meeting held on 12.08.2025 , vide paper read (6) above, approved the decisions of the FYIMP Implementation Committee regarding the fixing of course fee and the Syndicate decision has been implemented.
6. Hence, orders are issued fixing the fee for various courses under FYIMP as detailed above.
