A sum of Rs. 590/- (Including GST@18%) towards the cost of tender form (**Tender form is available in the University website**) and an amount of Rs. 5,220/- as EMD should be remitted separately by means of Demand Draft drawn in favour of Finance Officer, Kannur University, payable at SBI, South Bazar Branch, Kannur or Kannur branch of any other nationalized or scheduled bank.
4. The tenderer should send along with the tender an initial agreement executed and signed in Kerala stamp paper value of Rs. 200/- (**Format of the Agreement is available on the University website**)
5. The Contractor shall ensure that, before submitting the tender for the work, he visits the site and satisfies himself regarding the site conditions for construction, logistics, and the smooth movement of workmen and materials, with prior permission from the concerned authorities for



this purpose.

6. The tenderer shall have a valid GST registration and shall furnish a copy of the GST registration certificate along with the tender documents.
7. Asst. Engineer (Civil), Kannur University shall be the Engineer-in-Charge.
8. The defect liability period shall be 2 year(s) from the date of completion of work, and the contractor shall be responsible to maintain all his works till completion of the defect liability period and to hand over the work to the Engineer-in-charge.
9. The successful tenderer before signing the agreement and within the period specified in the Work Order, shall deposit a sum equivalent to 5% of the value of the contract as security deposit.
10. The rate quoted should be inclusive of GST and all other charges, if any. The base rate, GST charges, and other charges, if any should be furnished separately. Any request for payments over and above the rate quoted will not be entertained.
11. Payment will be made through bank account and no advance payment will be sanctioned.
12. Received tenders will be opened on 12.01.2026 at 3.30 PM.
13. Tender schedule is appended.
