#### 1. INTRODUCTION

Kannur University invites Expression of Interest (EOI) from reputed Insurance Companies/IRDAI Licensed General Insurance Providers for providing Group Personal Accident Policy (GPA) for its 18,013 Regular students for the academic year 2025-26

The objective of this policy is to ensure financial protection to students against unforeseen accidents leading to death or disability.

# 2. SCOPE OF COVERAGE

The proposed Group Personal Accident Policy (GPA) should cover all enrolled 18,013 Regular students for the academic year 2025-26.

The scheme will be implemented with an annual premium contribution up to ₹ 200/- per student.

THE KEY REQUIREMENTS ARE
Accidental Death Benefit (Lump sum payment to nominee in case of accidental death) (Including death due to snake bite, dog bite animal attack (eg, Elephant attack) or other accidental causes)
Permanent Total Disability (PTD) due to accident
(Resulting from accidents including animal attacks /insect bite)
Permanent Partial Disability (PPD) due to accident
(Resulting from accidents including animal attacks /insect bite)
Medical expenses due to accident/Injury (if applicable)  Due to accident ( if required) including treatment expenses for snake bite dog bites animal attack or other accidental injuries.
Funeral/Transportation expenses (if offered)
Sum insured for students Accidental Hospitalization Expenses (In Patient)
Sum insured for students Accidental Hospitalization Expenses (Outpatient)
Any other value-added services offered

In this policy' Accident" shall mean a sudden unforeseen & involuntary event caused by external, visible & violent means including bites/attacks by animal or insects.

The coverage should be valid 24 hours including while students are engaged in academic sports extracurricular and personal activities.
