## **ORDER**

- 1. University orders were issued vide paper read (1) sanctioning TA / DA / Honorarium to resource persons handling classes for the Coursework Programme at the rates applicable to resource persons invited by the UGC Academic Staff College.
- 2. The revised Regulations for Ph.D. Programme viz., "Kannur University Minimum Standards and Procedure for the Award of Ph.D. Degree Regulations, 2018" was implemented in the University and formal orders issued vide paper read (2).
- 23. As per the paper read (3), the Director, Research Directorate submitted a proposal for revising the remuneration to Resource persons handling classes for coursework programme.
- 4. Vice Chancellor, while considering the proposal, permitted the same with direction to place the matter before the Syndicate.
- 5. Accordingly, Syndicate of the University in it's meeting held on 28.10.2021 considered the proposal for revising Honorarium / TA / DA to Resource persons handling classes for the Ph.D. programme in tune with UGC Human Resource Development Centre rates and vide paper (4) approved the same.
- 6. The resolution of the syndicate has been implemented by the Director, Research Directorate as per the powers vested on him vide paper read (4).
  - 7. The following orders are therefore issued on the matter.
- i). Out station Resource persons invited for taking classes for coursework will be paid TA/DA as per UGC Human Resource Development Centre norms applicable from time to time excluding honorarium.
- ii). Honorarium to outstation / local resource person shall be paid @ Rs. 1500/- per person per session of 90 minutes duration with a ceiling of ₹3000/- per day. This will be subject to maximum of ₹12,000/- per course (six month duration).

- iii). Outstation Resource persons may be invited more than once in a programme as the course work programme is fixed for 6 months duration.
  - iv). Research Guides are eligible for TA/DA. Honorarium will not be paid to them.
  - iv). Eligible TA / DA will be given to local resource persons.
- v). The enhancement of Honorarium / TA / DA will be made applicable with the Course Work Programme for Ph.D. Programme 2020 21.
- 8. U.O. read as paper (1) above is revised accordingly.
