ORDER

- 1. A group of Students and Kerala Urdu Teachers Association vide paper read (1) requested to consider the Adib-i-Fazil (Urdu) Preliminary programme (2016, new scheme) of the University of Calicut, as an Eligibility criteria for admission to the B.A. Urdu and Islamic History dual core programme under Private Registration.
- 2. Subsequently, the Remarks of the Chairpersons, Board of Studies(BoS) in Urdu and BoS, Islamic History were sought in this matter. The Chairpersons vide paper read 2, recommended to include Adib-i-Fazil (Urdu) Preliminary programme of the University of Calicut as an Eligibility criteria for admission to B A Urdu & Islamic History dual core Programme under Regular & Private Registration stream of Kannur University.
- 3. Considering the Remarks offered by the Chairpersons of the BoS in Urdu and Islamic History, the Vice Chancellor ordered to place the same before the Standing Committee of the Academic Council consideration.
- 4. The Standing Committee of the Academic Council vide paper read 3, considered this matter and entrusted the Vice Chancellor to take appropriate decision, based on the Recommendations of Board of Studies
- 5. Consequently, the matter was placed before the *combined Meeting* of the BoS in Urdu and Islamic History and the Meeting, vide paper read (4) recommended to consider Adib-i-Fazil (Urdu) Preliminary programme (2016, new scheme) of the University of Calicut as an Eligibility criteria for admission to the B.A. Urdu and Islamic History-dual core programme under the 'Regular' and 'Private Registration' streams of Kannur University.
- 6. The Standing Committee of the Academic Council held on 07.10.2024, vide paper read 5 recommended to fix this Eligibility w.e.f. the academic year 2024-25.
- 7. Considering the whole matter, the Vice Chancellor, exercising the powers of of Academic Council conferred under the Section 11(1) Chapter III of Kannur University Act, 1996, accorded sanction to include Adib-i-Fazil (Urdu) Preliminary programme (2016, new scheme) of the University of

Calicut as an Eligibility criteria for admission to the B.A. Urdu and Islamic History dual core programme under the Regular and Private Registration streams of Kannur University w.e.f 2024-25 admission, subject to reporting to the Academic Council.
