ORDER

As per the paper read (1) above, fee for various programmes in the Departments/Centers under University was revised w.e.f 2019-20 Academic year onwards. As per this order NRI fee for MCA students in the Department of Information Technology, Mangattuparamba Campus is fixed as 1,43,325/- (Rupees One Lakh Forty Three Thousand Three Hundred and Twenty Five only) per year.

As per the paper read (2) above, Smt. Shylaja p, Assistant Professor and former Head of the Department. Department of Information Technology, Mangattuparamba Campus submitted a letter to the Hon. Vice Chancellor, stating that, in the fee revision order dated 17.06.2019 , the mode of NRI fee for MCA students in that Department is seen erroneously fixed as per year instead of per seat . Smt Shylaja. P further requested to correct this clerical error in the University order vide paper read (1) above, in order to clear the audit objection in this regard. The Hon. Vice Chancellor considered the submission of Smt Shylaja. P and instructed to place the matter before the Syndicate. Accordingly the matter was placed before the Syndicate for consideration.

The meeting of the Syndicate as per the paper read (3) above, considered the matter and resolved to conduct a hearing with Smt. Shylaja.P, Assistant Professor and Head of the Department by the Standing Committee on Course, Research, Library and Publication (CRLP) in this regard.

Accordingly, the Standing Committee of the Syndicate on CRLP conducted a hearing in this matter on 10.02.2022 with the Smt. Shylaja. P and Head of the Department of IT and recommended as follows as per the paper read (4) above.

"On verification of the documents available in the IT Department and the University there is an ambiguity in the University Orders, Prospectus and Hand Book with regard to the fee structure of MCA Programme in the Department of IT, Mangattuparamba and considering the shortage of applicants in the NRI quota, the committee recommended to fix the NRI fee per seat instead of per year for the MCA Programme. The University order issued in 2019 has to be revised accordingly"

Subsequently, as per the paper read (5) above, the meeting of the Syndicate approved the recommendations of the Standing Committee of the Syndicate on CRLP in this regard.

So the following orders are therefore issued in this regard as approved by the Vice Chancellor

i) The NRI fee for the MCA students admitted in the Department of IT w.e.f Academic Year

2019-20 onwards is refixed as 1,43,325/- (Rupees One Lakh Forty Three Thousand Three Hundred and Twenty Five Only) per seat instead of per year.

ii) The MCA Students admitted in the Department of IT under NRI quota w.e.f in the Academic Year 2019-20 onwards should remit all other fees as stipulated in the University Order as per the paper read (1) above.

iii) The University order read as per the paper read (1) above stands modified to this extent. orders are issued accordingly
