ORDER

1. As per paper read(1), the modified Regulations for MCA Lateral Entry programme stipulate that the Lateral Entry candidates need to acquire 9 more credits by attending three courses viz: i) MCA 7C07 Discrete Mathematics ii) MCA 2 C77 Principles of Management & iii) MCA2C72 Computer Graphics.
2. The aforesaid condition was implemented with effect from 2019 admission onwards for MCA Lateral entry candidates, exempting the MCA Lateral entry candidates of 2017 and 2018 admissions.
3. Meanwhile, the MCA candidates of 2019 admission also had completed their course without appearing the aforementioned three additional courses and as per paper read (2), they requested to exclude them also, from appearing for the three additional courses, as exempted in the case of 2017 and 2018 admission candidates.
4. As per paper read (3), the Examination Branch sought clarification on the procedures to be followed with respect to the MCA[Lateral Entry] candidates 2019 admission, informing that those students have completed the course without appearing for the three additional courses, as mentioned in Para 1 above and awaiting result. This was happened due to the delay in reaching the information about the additional courses in Colleges, well in advance.
5. As per paper read(4), Remarks of the Board of Studies in Computer Science (PG) was sought in this regard.
6. Subsequently, the Meeting of the Board Studies in Computer Science (PG), held on 02.11.2021, recommended as per paper read (5), to exempt 2019 admission MCA Lateral Entry candidates from appearing the three additional courses.
7. The Vice Chancellor, after considering the matter in detail and in exercise of the Powers of the Academic Council, conferred under Section 11 (1) Chapter III of Kannur University Act 1996, accorded sanction to modify the Regulations for MCA Lateral Entry programme and to exempt MCA Lateral Entry candidates of 2019 admission from appearing the three additional courses [i) MCA 7C07 Discrete Mathematics ii) MCA 2 C77 Principles of Management & iii) MCA2C72 Computer Graphics], subject to reporting to the Academic Council.
8. The U.O. read as paper (1) above stands modified to this extent.
Orders are issued accordingly.
