ORDER

- 1. Eligibility criteria for admission to M.Sc Chemistry Programme CBSS (w.e.f 2014) and M.Sc Chemistry with Drug Chemistry Specialization programme (CBSS) w.e.f 2020-21, in the respective Syllabi as per paper read (1) and (2) is, "Candidate with bachelor degree in Chemistry with Mathematics and Physics as subsidiary subjects are eligible for admission to these course. Rules regarding minimum marks required for the bachelors degree, reservation etc"
- 2. As per paper read (3) above, XXIV meeting of Academic Council resolved to modify the Eligibility Criteria for M.Sc. Chemistry Programme as B.Sc. Chemistry, in connection with the ratification of admitting an ineligible candidate to MSc Chemistry with Drug Chemistry Specialisation Programme w.ef 2020, and Single Window Section as per paper read (4) above, requested to modify the Eligibility Criteria of M.Sc Chemistry Programme .
- As per paper read (5) above, Single Window Section was requested to clarify whether the Eligibility Criteria of M.Sc Chemistry Programme CBSS(w.e.f 2014) or that of the New generation Programme MSc Chemistry with Drug Chemistry Specialization programme (CBSS) w.e.f 2020-21 is to be modified.
- 4. As per paper read (6) above, Vice-Chancellor, after considering the matter in detail and in exercise of the powers of the Academic Council conferred under Section 11(1), Chapter III of Kannur University Act 1996, accorded sanction to fix the Eligibility for admission to M.Sc Chemistry programme (CBSS) w.e.f 2014 and also that of New Generation Programme M.Sc Chemistry with Drug Chemistry Specialization Programme (CBSS) w.e.f 2020-21, in affiliated colleges as B.Sc Chemistry (without any Mark stipulation) and to report the same to Academic Council.
- 5. The modified Eligibility Criteria for admission to M.Sc. Chemistry programme (CBSS) w.e.f 2014 and M.Sc Chemistry with Drug Chemistry Specialization programme (CBSS) w.e.f 2020-21 in affiliated colleges applicable w.e.f 2023 admissions are uploaded on the University website (www.kannuruniversity.ac.in)
