ORDER

1. As per paper read (1) above, revised Scheme and Syllabus of M.Sc Environmental Science programme (CBCSS) were implemented w.e.f 2020 admission in Department of Environmental Studies, Mangattuparamba Campus.

As per the Syllabus of M.Sc Environmental Science Programme (CBCSS), the Eligibility Criteria for admission is fixed as "B.Sc Degree in any of the subjects (Botany/ Zoology/ Chemistry/ Physics/ Environmental Science/ Environmental Management/ Microbiology/Biotechnology/ Biochemistry/ Agriculture/ Horticulture/ Forestry/ any branch of Life Science/Geology/ Geography) with 50% marks or equivalent grade in Core Course Or an Engineering Degree in Civil/ Mechanical/Chemical/ Environmental branch with an aggregate of 55% marks in the optional."

3. As per paper read (2) above, the Examination branch sought clarification from Single Window Cell whether B.Sc Environment & Water Management programme of Calicut University can be considered as Eligibility for Admission to M.Sc Environmental Science programme of Kannur University w.e.f 2022

4. As paper paper read (3) above, the Head, Department of Environmental Studies, remarked that BSc Environment and Water Management Programme can be an eligible degree programme for admission to MSc Environmental Science programme (CBCSS) at Kannur University and the same was approved by the Vice Chancellor on 23-2-2023 in file no. SWC/7294/2022 as intimated vide paper read (4).

5. Accordingly, the Single Window Cell, as per paper read(4) above requested to modify the Eligibility Criteria for admission to MSc Environmental Sciences

6.Therefore, as approved by the Vice Chancellor, in exercise of the powers of the Academic Council conferred under section 11 (I) of KU Act 1996, the following orders are issued.

B.Sc Environment and Water Management Programme is approved as an eligible degree programme for the admission to M.Sc Environmental Science Programme (CBCSS) in addition to other programmes approved as eligible for admission with the same requirement of percentage marks other than B.Tech, at the Department of Environmental Studies, Mangattuparamba Campus w.e.f 2022 admission.
