The Chair welcomed the members of the Senate and called the meeting to order at 10 a.m and initiated the procedure for nominating one academic to the panel for selecting Vice-Chancellor for Kannur University

With the permission of the chair , Smt.K.K.Shailaja Teacher, M.L.A proposed the name of Dr.Ajayakumar P.P, former Pro-Vice-Chancellor, University of Kerala, Professor, Emeritus Institute of English, University of Kerala, Palayam, Thiruvananthapuram. The name of Dr.Ajayakumar P.P, was seconded by Sri.Saju.P.J, Member, Senate.

With the permission of the chair , Dr.Shino P.Jose, Member, Senate proposed the name of Dr.Achuthsankar S.Nair, former Dean and Senior Professor, University of Kerala, Director, C-DIT, Govt. of Kerala. The name of Dr.Achuthsankar S.Nair was seconded by Sri. Muhammed Ashefas C.H, Member, Senate

Names of Dr.Ajayakumar P.P. and Dr.Achuthsankar S.Nair.were placed before the Senate. Voting was conducted and 50.members out of the 66 members present voted in favour of Dr.Ajayakumar P.P and 14 members voted in favour of Dr.Achuthsankar S.Nair. Two members chose to abstain from voting.

Four members, who arrived after the completion of the election procedure, were unable to cast their votes.

After the election process, the Chair declared that Dr.Ajayakumar P.P, former Pro-Vice-Chancellor, University of Kerala, Professor, Emeritus Institute of English, University of Kerala, Palayam, Thiruvananthapuram has been elected as the nominee of the Senate, as member for constitution of the Committee as per Chapter III, Section 10 (2) of Kannur University Act 1996.

The meeting came to an end at 10.15 a.m.
