Minimum qualification prescribed for the post of Assistant Professor as per UGC Regulation 2018 . The Assistant Professor on tenure basis shall be eligible for a consolidated remuneration of Rs. 42,000/- per month.

Age Limit as on 01.01.2023

Maximum age will be 65 years as on 01/01/2023.

General Instructions:

1. The appointments on contract basis shall be for a period of 2 year tenure basis from

the date of joining or till the University issues further orders/decides to terminate the engagement whichever is earlier.

- 2. The appointments will be made after conducting interview in each subject.
- 3. Dates of interview will be published on University website only. No individual communication will be sent to the applicants.
- 4. The documents should be scanned as different pages of a single 'pdf' file in the following order:

 - b. SSLC book
 - c. Plus Two or Equivalent Certificate
 - d. Non-creamy-layer certificate/Community certificate(if applicable)

 - h. Percentage certificate (in case where only the CGPA is given)
 - i. Experience certificate(if any)
 - j. Any other certificates relevant for the post

- Candidates who have passed their qualifying examination through distance mode from Universities outside Kerala and those have regular degree with different nomenclature should produce equivalency certificate obtained from this University at the time of interview/ Certificate verification.

- Candidate should produce original certificate to prove age, qualification, experience and community(Non-creamy- layer certificate to those belong ng to OBC) at the time of interview.
