NOTIFICATION

It is notified that the following amendments to Ordinance 3(1) of Chapter XV 'The Scale of pay, age, etc. for non-teaching posts' of the Kannur University Ordinances 1999 (post no.2, 3, 7, 7A, 8 & 8A in the schedule) passed by the Syndicate at its meeting held on 25/09/2020 and 30/01/2023 have been assented to by the Chancellor on 21/04/2023.

The amendments to Ordinances shall be deemed to have come in to force with effect from 21/04/2023.

Amendments to Ordinance 3(1) of Chapter XV- 'The Scale of pay, age, etc. for non-teaching posts' of the Kannur University Ordinances, 1999.
