1. As per paper read 1<sup>st</sup> above, an application was received for the recognition of M.Sc Chemistry with Drug Chemistry Specialization (regular) degree of Kannur University as equivalent to M.Sc Chemistry Degree of Kannur University.

As per the paper read 2<sup>nd</sup> above, the XXV Academic Council meeting held on 14.12.2022, considered the resolution No: 6(1) demanding to take appropriate actions to get the approval of PSC for the new generation courses started in various colleges under Kannur University, and steps should be taken to get the then new generation courses like BA Functional Hindi which started years ago to be at par with similar courses and subjects as soon as possible and the Academic council passed the resolution resolving that the equivalency shall be given to all candidates who pursued New Generation Courses to that of similar degree conducted by the University. The Hon'ble Vice Chancellor has approved the minutes of XXV meeting of the Academic Council.

3. As per the paper read 3<sup>rd</sup> above, the meeting of the Senate Held on 28.12.2022, passed the resolution No.17 demanding that in order to provide opportunities for further study and employment opportunities for the students of Kannur University, the new generation programs started at the university should be equated as appropriate with the existing programs. Steps should be taken to obtain recognition by PSC.

4. As per the paper read 4<sup>th</sup> above the Syndicate has approved the resolution no.17 passed by the Senate held on 28.12.2022. The resolutions of the syndicate has been implemented.

5. After considering the matter in detail, the Vice Chancellor has ordered to equate M.Sc Chemistry
