**ORDER**

1. University started a Community College at PHAPINS Institute of Positive Health and Psychological Solution, Thankayam, Trikaripur, Kasaragod, for the conduct of Post Graduate Diploma in Counselling (PGDC) and Post Graduate Diploma in Learning Disability (PGDLD) as per the terms and conditions laid down vide paper read 1<sup>st</sup> above.

2. As per paper read 2<sup>nd</sup>, the regulation and scheme fixed from 2014 admission onwards, the basic eligibility for admission to PGDLD course is a Degree in any subject from a recognized University with a minimum of 50% marks or equivalent Grade/CGPA/GPA.

3. The Co Ordinator, PHAPINS Community College of Behaviour Management vide paper read 3<sup>rd</sup> above has requested to change the minimum eligibility criteria fixed for admission to PGDLD course as 'aggregate 50% marks in any Degree'.

4. The matter was referred to the Board of Studies in Psychology (Combined). The Board of Studies in Psychology (Combined), in its meeting held on 11.04.2016 considered the matter and decided to change the existing eligibility criteria to 'Pass in any Degree from a recognized University'.

5. The Vice Chancellor, having considered the matter in detail, has accorded sanction to revise the eligibility criteria of PGDLD course as 'Pass in any Degree from a recognized University' with effect from 2016 admission.
