ORDER

1. The regulations of Post Graduate Programmes in affiliated Colleges implemented w.e.f 2001 admission as per paper read (1) above and the regulation for M.Sc Computer Science Programme implemented w.e.f 2004 admission as per paper read (2) above states that "candidates who have failed in the semester exams can appear for the failed papers for particular semester along with the regular students and two such Supplementary chances will be given for each semester". Based on this, results of the students who have utilized more than two supplementary chances were withheld by the exam branch. Similarly Hall Tickets of the students who had applied for supplementary chances beyond the stipulated limit were also withheld.

- 2. After considering the representation from the students to release their results and to provide more chances to appear for examinations so as to pass the course, as ordered by the Vice Chancellor, the matter was placed by the examination branch before the syndicate for consideration. The syndicate as per paper read (3) above resolved "to provide mercy chance with a fee of Rs.1000/-(Rupees one thousand only) per paper and re-registration fee of Rs 5000/-(Rupees five thousand only). Candidates are to avail this facility before December 2018. Further resolved to release the withheld results, except on cases pending in Court, by levying a fee of Rs.1000/- (Rupees one thousand only) per paper and re-registration fee of Rs.5000/- (Rupees five thousand only)".
- 3. The Vice Chancellor after considering the matter in detail, and in exercise of the powers of the Academic Council conferred under section 11(1) of KU Act 1996, and all other enabling provisions read together with, has accorded sanction to issue following orders subject to report to the Academic Council.

- a) Students who have completed PG courses from affiliated colleges of this university, as per the scheme and syllabus applicable for 2013 and earlier admissions and who have not passed the course are permitted to avail mercy chance (upto December 2018) for the failed papers of the semester, as and when the examinations are offered by the university, after re- registering for the PG course with a fee of Rs.5000/-(Rupees five thousand only). Examination fee for such candidates will be Rs.1000/-(Rupees one thousand only per paper.)
- b) Results, of the candidate which are withheld on reasons mentioned at Para one above, will be released after re-registering for the PG course with a fee of Rs.5000/-(Rupees five thousand only). Examination fee for such candidates will be Rs.1000/-(Rupees one thousand only). In the case of petitions pending before the Honourable High Court of Kerala, results will be released on the final disposal of the petitions.
- 4. Orders are, therefore, issued accordingly.
