**ORDER**

1. Three consecutive chances were already given to all B. Tech students for internal (sessional) improvement, without insisting the year of admission vide paper read 1,2 and 3 above and this facility was also extended to all candidates, who have already availed the facility as per earlier notifications (but failed), as per the conditions stipulated in the guidelines issued along with the University Orders.

2. However, B. Tech Students of various branches, who could not pass the programme, have requested to grant one more chance to attend sessional improvement examination stating various reasons.

3. After considering the representations from the students, the Vice Chancellor ordered to place the matter before the Syndicate, and the syndicate held on 04.07.2023 vide paper read 4 above resolved to entrust Controller Of Examinations to seek the remarks of the Principal, Govt. Engineering College, Kannur in this matter.

4. Accordingly, the Principal, Govt Engineering College, Kannur intimated his willingness to conduct the examination and assured to provide essential assistance required for the successful completion of the examination vide paper read (5) above.

5. The Syndicate held on 12.12.2023, vide paper read (6), considered the remarks furnished by the Principal, Govt. Engineering college, Kannur and resolved to conduct B. Tech Internal (sessional) Improvement Examination with a fee of Rs 2500/- (Rupees Two thousand Five Hundred only) per paper as examination charges to be levied by the college and Rs. 2500/- (Rupees Two thousand Five Hundred only) per paper as Registration fee to be paid to the University.

6. *The resolution of the syndicate has been implemented* and the Vice Chancellor, after considering the matter in detail and in exercise of the powers of the Academic Council conferred under section 11 (1) Chapter III of Kannur University Act 1996, ***accorded permission to grant one more chance for Sessional Assessment (Internal) improvement for B.Tech programme, and to modify Clause (9) of the guidelines issued vide paper read 3 above as follows, subject to report to the Academic Council.***

***Clause 9 : Fee of 2500/- (Rupees Two thousand Five Hundred only) per paper as***



**The Modified Guidelines for the improvement of Sessional Assessment(Internal) marks of B.Tech programmes.**

- 1.All B.Tech students who have completed the course are given a chance to improve their Internal Assessment marks in the failed subjects only, at the colleges where they have completed the programme.
2. The benefit of granting internal improvement is also extended to those candidates who have failed to score 40% of the external theory examination conducted by the University.
3. In case of candidates who have completed the course, but failed in any number of papers can make use of this opportunity irrespective of year of admission.
4. The provision for improvement of Internal marks is given for all papers of the whole B.Tech programme, for which the candidate has availed facility for improvement of internal assessment marks as per the earlier notifications, but failed in the internal assessment.
5. There shall be only one chance to improve the internal marks of a subject for such candidate
- 6.If a candidate already has the required internal marks for getting minimum marks for a pass (35 marks) in a paper, the candidate is not eligible for improvement of internal marks of such papers.
- 7.The improvement of internal (sessional) assessment is to be done as per the procedure prescribed for regular students in the concerned Regulations of B.Tech. programmes.
- 8.The maximum internal marks awarded for each subject shall not exceed 70% of maximum internal marks for the subjects.
- 9.Fee of Rs.2500/-(Rupees Two Thousand and Five Hundred only) per paper as Examination charges is to be collected by the college and Rs. 2500/(Two Thousand and Five Hundred only) per paper as Registration fee, is to be paid to the University fund.
- 10.The candidate has to submit separate application for the improvement of internal marks of each semester with the required fee for each semester, duly recommended by the Principal of the college concerned. Corresponding fee is to be paid to the college concerned
- 11.The Improved internal marks is to be given in the session in which candidate has scored the highest external mark in the subject.(The candidate should submit copy of the mark list along with the application for internal marks improvement).
- 12.The month and year of passing the Internal Improvement exam will be considered as the month and year of passing the subject.
13. A maximum of 45 days shall be given for completing the Internal Assessment process.
- 14.The department of the college concerned should conduct necessary assignments, test papers etc, as prescribed in the Scheme and Syllabus, as part of internal assessment.
15. The Department should assign specific days of work to the candidate to assess the marks for Attendance, if required.
16. The internal assessment marks duly signed by the teacher in charge of conduct of the exam and the Head of the Department, should be forwarded to the controller of Examinations through the Principal of the college concerned within 10 days, after the completion of assessment.
17. The students shall be declared pass if he/she gets the internal marks improved and total marks secured after internal improvement plus marks in University examination satisfies the pass minimum condition of the University.
