

Ph.D. Programme – Ph.D. registration to teachers of unaided colleges other than Kannur University – Not eligible for Ph.D. registration on Part-Time basis — orders issued.

ORDER

- 1. The Regulations for Ph.D Registration and award of the Degree of Doctor of Philosophy 2011 was implemented in this University with effect from 01-01-2011, in compliance with the UGC Regulations on minimum Standards and Procedure for the Award of Ph.D Degree Regulation 2009.
- 2. As per Clause 7.1 of the "Regulations for Ph.D. Registration and Award of degree of Doctor of Philosophy-2011", Part-Time Ph.D. registration is permissible only to Teachers of Affiliated Colleges/University Departments/ Higher Secondary Schools, candidates appointed as Research Fellows or Research Assistants in Research Projects run in the University Departments/ Affiliated Colleges/ Research Institutes and Scientists working in the Research Institutes. Technical experts working in analytical laboratories, members of any statutory professional institutions approved by the Government of India, Permanent employees of Kannur University, Clinical psychologists working in Government Medical Colleges and Government Hospitals, High School and DIET Teachers, satisfying the eligibility criteria for admission as stated under 2.1. of the Regulation, for doing research.
- 3. As per the Guidelines for granting Part-Time Ph.D. Registration to Course Work leading to Ph.D. Programme for Guest Lectures, issued vide the paper read as 2 above, Part-Time registration to Ph.D. Programme may be granted to UGC-NET qualified Guest Lecturers, who have minimum two years of teaching experience and is working in Government/Aided Colleges/University Departments affiliated to Kannur University, subject to the consideration of the Syndicate, by assessing the Academic credentials of the candidate.
- 4. Many teachers of self-financing colleges outside the territorial jurisdiction of the Kannur University have requested to grant them Part-Time registration to Ph.D. programme and conversion of Ph.D. registration from Full-Time to Part-Time.
- 5. The matter of grating Part-Tine registration and conversion of Ph.D. registration from Full-Time to Part-Time to teachers of self-financing colleges of other universities in Kerala and outside the Kerala was placed before the Syndicate. The Syndicate vide the paper read as 3 above, resolved not to grant Part-Time registration to teachers of unaided colleges other than Kannur University and further resolved to grant conversion registration from Full-time to part-Time to applicants who have already applied provided that they should complete the research one year minim im on Full-Time basis excluding Course Work period.

- The following orders are, the efore, issued in the matter as approved by the Vice Chancellor, by implementing the Syndicate resolution.
 - Teachers of unaided/self-financing colleges affiliated to other universities/outside the 1. jurisdiction of Kannur University are not eligible to get Ph.D. registration on Part-Time basis.
 - Research Scholars, who are working as teachers of unaided/self-financing colleges ii. affiliated to other universities/outside the jurisdiction of Kannur University and who have already applied for conversion, before the date of Syndicate decision (28-04-2017) and completed the research for one year minimum on Full-Time basis excluding Course Work period are eligible to get conversion of their Ph.D. registration from Full-Time to Part-Time.
