## ORDER

1. The Regulations for Ph.D Registration and award of the Degree of Doctor of Philosophy 2011 was implemented in this University we'f 01-01-2011, in compliance with the UGC Regulations on minimum Standards and Procedure for the Award of Ph.D Degree Regulation 09.

2. As per regulations, coursework was made mandatory to all Ph.D Programmes. As per this regulation candidates registered for coursework shall undergo a coursework of six months/one semester duration and all shall appear for the Preliminary Qualifying Examination within one year of getting registration. The Preliminary Qualifying Examination Consists of two theory papers, Dissertation and Viva-voce.

3. The coursework for 2015-16 batch was started on 01-12-2015 at each coursework centres

identified for the particular subject.

4. Vide the reference read 2 above, the scholars who have completed coursework were permitted to attend the concerned research centres from the very next day of completion of coursework

5. The research scholars who have completed coursework during 2015-16 had to submit their Preliminary Dissertation by 30 November 2016, ie. within one year of registering to PhD programme (ie. Joining to coursework).

6. Some research scholars have requested to extend the time further upto 31-03-2017 due to various reasons like delay in the conduct of doctoral committee.

- 7. Vide the reference read (3) above, the Syndicate resolved to grant extension of time for the submission of Preliminary dissertation upto 31-03-2017 to the scholars without fine.
- 8. The following order is therefore issued on the matter as approved by the Vice Chancellor by implementing the Syndicate resolution.

The time limit for the submission of Ph.D Preliminary Dissertation for those research scholars who have completed coursework during 2015-16 batch is extended upto 31-03-2017.
