ORDER

1. As per the the papers read as (i) to (iii) above, the recommendations of the various Boards of Studies regarding the Recognition/Equivalence of Degrees of other Universities/Kannur University were placed before the meeting of the Standing Committee of the Academic Council, for consideration. Subsequently, the meeting of the Standing Committee of the Academic Council, held on 05.03.2025, vide the paper read as (iv) above, considered the recommendations of the various Boards of Studies on the matter of Recognition of Degrees of other Universities/Kannur University and recommended to approve the recommendation to recognize the following Degree as detailed below.

2. The meeting of the Standing Committee of the Academic Council also recommended to approve the following recommendations of the various Boards of Studies,

i) Not to recognize the B.Sc - B.Ed Chemistry, Botany, Zoology (Regular) degree of Regional Institute of Education under Mysore University as equivalent to the B.Sc Zoology Degree of Kannur University for any purpose.

ii) Not to recognize the M.Sc Medical Laboratory Technology (Regular) Degree of Kannur University as equivalent to the M.Sc Biochemistry Degree of Kannur University for any purpose.

iii) Not to recognize the B.Sc Biochemistry (Regular) Degree of Kannur University as equivalent to the B Sc Biotechnology Degree of Kannur University. However, candidate with a B Sc Biochemistry will be deemed eligible for higher studies in Biotechnology.

3. After considering the matter in detail, the Vice Chancellor, exercising the powers of the Academic Council conferred as per the Section 11(1), Chapter III of Kannur University Act, 1996, approved the aforesaid recommendations of the Meeting of the Standing Committee of the Academic Council held on 05.03.2025 (item No. 4, 28 & 30) and accorded sanction to recognize the aforesaid Degree awarded by Mangalore University, as detailed in the table above and also approved the recommendation of Standing committee of the Academic Council as detailed in Para 2 above, subject to reporting the matter to the Academic Council.
