ORDER

1. As per the the papers read as (i) to (iii) above, the Recommendations of the Expert Committee and Boards of Studies regarding the Recognition/Equivalence of Degrees of other Universities/ Institutions were placed before the consideration of the meeting of the Standing Committee of the Academic Council.
2. The meeting of the Standing Committee of the Academic Council, held on 30.08.2024, vide the paper read as (iv) above, considered the matter of Recognition of Degrees of other Universities and resolved to recognize the following Degrees awarded by the University of Calicut, as detailed below.

The Standing Committee of the Academic Council has also recommended **not to recognise** the B.Sc.B.Ed. - Chemistry, Botany, Zoology (Triple Main, Regular) Degree of the VELS Institute of Science Technology and Advanced Studies (VISTAS) (Deemed to be University), Chennai, as equivalent to the B.Sc.Zoology Degree of Kannur University, as suggested by the Board of Studies in Zoology (UG).

4. After considering the matter, the Vice Chancellor, exercising the powers of the Academic Council conferred as per the Section 11(1), Chapter III of Kannur University Act, 1996, approved the Recommendations of the Meeting of the Standing Committee of the Academic Council held on 30.08.2024 (item No. 7-8 & 12) and accorded sanction to Recognize the two aforesaid Degrees awarded by the University of Calicut, as detailed in the Table above and also approved the Recommendation of Standing Committee of the Academic Council regarding the B.Sc.B.Ed. Degree of the VELS Institute of Science Technology and Advanced Studies (VISTAS), as detailed in Para 3 above, subject to reporting to the Academic Council.
