ORDER

1. The Regulation, Scheme, Syllabus & Model Question Paper of Two year Bachelor of Education (B.Ed) Degree in tune with NCTE Regulations 2014 were implemented in Kannur University with effect from 2015 admission as per paper read (1) above.

2. As per the above Regulations, the Eligibility for admission to B.Ed Degree in Social Science is "B.A Degree with History/ Arabic and Islamic History/ Urdu and Islamic History/ Geography/ Politics/ Economics/ Sociology/ Psychology/ Philosophy/ West Asian Studies with 50% marks or equivalent CGPA/GPA in Part I+ II+ III together (Common, Core, Complimentary and Open Courses) or Part III (Core and Complementary courses) alone or 50% marks in M.A History/ Arabic and Islamic History/ Geography/ Politics/ Economics/ Sociology/ Psychology/ Philosophy/ West Asian Studies/ Rural & Tribal Sociology/ Tribal & Rural Studies". The Eligibility for admission to B.Ed Degree in Physical Science is B.Sc Degree with Physics/ Chemistry/ Polymer Chemistry/ Geology/ Petrochemicals/ Bio Chemistry/ Industrial Chemistry main with 50% marks or equivalent CGPA/GPA in Part I+II+III together (Common, Core, Complementary and Open Course) or Part III (Core and Complementary Courses) alone or 50% marks in M.Sc Physics/ Chemistry/ Polymer Chemistry/ Geology/ Petrochemicals/ Bio Chemistry/ Industrial Chemistry/ Photonics (integrated from CUSAT).

3. Meanwhile, the Course Director, Kannur University Teacher Education Centre, Kasaragod vide the paper read (2), has sought clarification whether the students with B.A Development Economics Degree are eligible for admission to B.Ed Degree in Social Science and also candidates having B.A Economics Degree with M.A Applied Economics, and candidates having B.Sc Chemistry Degree with M.Sc Polymer Chemistry are eligible for special weightage that is given to the Post Graduates for admission to the B.Ed Programme, as it is the branch of the main subject concerned. It was further informed by the Acad 'D' Section that the VC Clarified the matter and further requested to issue necessary orders in this regard and to report the same before the Academic Council.

4. Therefore the Vice Chancellor, in exercise of the powers of the Academic Council, conferred under Section II (1) of Kannur University Act, 1996 (i) The candidates with B.A Development Economics Degree are eligible for admission to the B.Ed Programme in Social Science. (ii) The candidates who passed B.A Economics Degree and subsequently obtained M.A Applied Economics Degree and those who passed B.Sc Chemistry Degree and subsequently obtained M.Sc Polymer Chemistry Degree are also eligible for the special weightage for admission to the B.Ed Programme, subject to ratification by the Academic Council.
