#### ORDER

- 1) As per the paper read (1) above, syllabus and Model question papers of the 'Alternative English' course prepared for the *Manipuri Students of BA LLB Programme*, instead of Malayalam insisted by the Regulations, Scheme and Syllabus of the BA LLB programme w e f 2021 admission at School of Legal Studies, Dr.Janaki Ammal Campus, Palayad, Thalassery was approved.
- 2) As per paper read (2) above, S Kowshiya, BA LLB, 6th semester student of School of Legal Studies, Kannur University, requested to allow her to opt Alternative English instead of Regional language (Malayalam) insisted by the BA LLB Regulation implemented w.e.f.2021 admission, since she is facing difficulty in learning Malayalam being a native of Tamil Nadu.
- 3) As per the Regulation and syllabus of BA LLB Programme w. e.f.2021 admission, additional Language is offered in IV, V and VI th semester. Considering the matter, it has been ordered to obtain remarks from the HoD as to the courses (additional language) selected by S Kowshiya, in the IV and V semesters.
- 4) Subsequently, Head of the Department vide the paper read (3) above, intimated that the candidate S Kowshiya has registered for all the examinations in IV and V semesters. However, she did not attend the additional Language Malayalam. HoD also recommended that 'Alternative English' be allowed as additional language to S Kowshiya, as she is from Tamil Nadu and has difficulty in learning Malayalam and also as a gymnast, representing Kannur University in All India level, she has limited time to dedicate to language learning.
- 5) Considering the aforementioned request and the remarks furnished by the Head of the Department in this matter, the Vice Chancellor has ordered to place the matter of allowing "Alternative English" as Additional Language to S Kowshiya and extending the provision to the students from outside Kerala in general, before the Standing Committee of Academic Council for consideration.
- 6) The Standing Committee of the Academic Council held on 05.03.2025 vide the paper read 4, considered the matter and recommended to approve the same.
- 7) The Vice Chancellor after considering the recommendations of the Standing Committee of Academic Council and in exercise of the powers of the Academic Council conferred under the section 11(1), chapter III of Kannur University Act 1996, approved the request of S Kowshiya, BA LLB student for opting Alternative English as Additional Language instead of Malayalam

insisted by the Regulation, scheme and syllabus of the Programme and also ordered to extend the provision to the students from outside Kerala in general and to report the matter to the Academic Council.
