ORDER

1. Clause 6.5 in the regulation of of the Post Graduate Programmes Under Choice Based Credit Semester System in the Schools/ Departments of Kannur University implemented with effect from 2010 admission as per paper read (1) above states that "the minimum duration for completion of a two year PG Programme in any subject is four Semesters. The maximum period for completion is eight (8) Semesters. The minimum duration for completion of a three year PG Programme in any subject is six (6) Semesters. The maximum period for completion is twelve (12) Semesters". Regulation of the B.P.Ed. Programme Under Choice Based Credit and Semester System in the Schools/ Departments of Kannur University is silent about the maximum duration for the completion of the Programme.

2.As per paper read (2) above, the Syndicate ratified the action of the Vice Chancellor in having permitted mercy chance examination for those candidates of 2015, 2016 & 2017 admission MA / MSc / MBA / MCJ / MCA / MLISc / LLM / MEd / MPed / BPEd ,who have already crossed the maximum period for completion of their course, as follows.

Examination Branch as per paper read (3) above, further informed that, 2015,2016, & 2017 admission candidates of MA / MSc/ MBA / MCJ/ MLISc / LLM / MEd / MPed / BPEd are granted one mercy chance along with the supplementary candidates following the same syllabus, with a reregistration fee of Rs 3000/- and Rs 1000/-per paper. Examination Branch also informed that Notification has already been issued for the conduct of I Semester November 2020 Supplementary (2015 Admission) Examinations of MA / MSc/ MBA / MCJ/ MLISc / LLM / MEd / MPed / BPEd and II Semester May 2021 Supplementary examinations of MA / MSc / MBA/ MCJ / MCA/ MLISc /LLM /MEd /MPed /BPEd .

The Vice Chancellor after considering the matter in detail and in exercise of the powers of the Academic Council conferred under section 11(1) Chapter III of Kannur University Act 1996, has accorded sanction to relax the Clause 6.5 of the regulation for Post Graduate Programmes Under Choice Based Credit Semester System in the Schools/ Departments of Kannur University implemented with effect from 2010 admission, and to conduct one Mercy Chance Examination for 2015, 2016 & 2017 admission candidates of MA / MSc / MBA/ MCJ / MCA/ MLISc / LLM / MEd / M P Ed Programmes and B P Ed Programme in the University Teaching Departments, as detailed in para 2 above. No further chance will be allowed to these candidates..
