ORDER

1. The clause 3.9 of the paper read (1) above, states that "Those candidates who have been awarded BCom degree of this University or BCom Degree of other University/Institution recognised as equivalent thereto, may be permitted to appear for Elective Papers of Co-operation of BCom programme under this regulations. Such candidates shall take examinations of papers in optional (Elective) Co-operation as per the scheme and syllabus of B.Com Private Registration. Examinations for four papers shall be conducted at the end of one academic year separately for these candidates. The Internal Evaluation be followed for additional Co-Operation with assignment, as in the case of other UG Programme under Private Registration. Successful candidates under this provision will be issued certificate of B.Com additional Co-operation signed by the Controller of Examinations".

2.As per the Clause 8.1 of the Regulation for Choice Based credit and semester system for Under Graduate programme under Private registration " the evaluation scheme of each course shall contain two parts : a). Internal Evaluation (IE) b). End Semester Evaluation (ESE)

3 . As the B.Com additional Co-operation programme doesn't follow the semester pattern and the examination for four papers are conducted at the end of one academic year separately for these candidates, the Director School of Distance Education suggested that the evaluation scheme of four papers for the same may be named as Internal Evaluation (IE) and End Evaluation.(EE)

4 . The Vice Chancellor, after considering the matter in detail and in exercise of the powers of the Academic Council conferred under Section 11 (1) Chapter III of Kannur University Act 1996 ***accorded sanction to name the evaluation scheme of four papers for B. Com additional Co-operation programme as Internal Evaluation (IE) and End Evaluation (EE) and to add the same as Clause 8.1 (a) in the Regulations for UG Programmes Choice Based Credit***

Semester System(OBE) under Private Registration, w.e.f 2022 admission.
