**ORDER**

1. As per paper read (1) & (2) above the Scheme, Syllabus and Model Question papers of the B.Sc.Zoology and B.Sc. Botany programmes respectively, were implemented in affiliated colleges w.e.f 2019 admission.
2. In the Scheme of Zoology programme, maximum marks for Complementary Elective course Botany is 40 (32+8), where as in the Scheme of Botany, it is 50 (40+10). Examination Branch as per paper read (3) above requested to clarify the anomaly in maximum marks.
3. Considering this, the Board of Studies in Zoology, vide paper read (4) above, recommended to modify the maximum marks of Complementary Elective Course Botany as '50' (40+10) and to distribute the 50 marks for Complementary Course Botany, as 40 marks for Theory (External Examination) and 10 marks for Continuous Evaluation.
4. The Vice Chancellor, after examining the matter in detail, and in exercise of the powers of the Academic Council as per section 11(1) Chapter III of Kannur University Act 1996 and all other enabling provisions read together with, has accorded sanction **to implement the aforesaid modifications detailed in para(3) in the Scheme and Syllabus of B.Sc. Zoology programme under CBCSS (OBE) with effect from 2019 admission**, subject to reporting to the Academic Council
