## **ORDER**

- 1. The Regulations for Post Graduate programmes under Choice Based Credit Semester System were implemented in the University w.e.f 2010 admission as per the paper read (1) above and certain modifications were effected to the same vide papers read (2), (3), (4) & (5).
- 2. As per paper read (3), the **sub Clause 4.1 of the Clause 4 Admission**, was modified as "Admission to all PG Programmes of the University Departments to be made purely on the basis of written test and the paper notification in this regard has to be made in the month of May itself. Entrance Exam is mandatory for all the Departments, even if the number of applicants are lesser than the sanctioned strength of the Department. The concerned Department can fill the vacancy by making necessary press release by fulfilling reservation norms, on the basis of the marks obtained in the qualifying examination. Resolved also to ensure uniformity in the date of starting the course and also in the conducting of End semester Examination".
- 3. Meanwhile, the Convener, Admission Committee, vide paper read (6) above, pointed out the practical difficulty in conducting Entrance Examinations in the present scenario of spreading COVID-19 pandemic and requested to admit students for the PG Programmes of 2020, based on the Marks obtained in the qualifying examination, as considered in other Universities of Kerala.
  - 4. A meeting of the Curriculum committee was convened on 18.08.2020 to discuss the matter.
- 5. The Meeting of the Curriculum Committee decided to relax the **sub Clause 4.1 of the Clause 4 Admission** in the existing Regulations of PG Programmes under Choice Based Credit Semester System in the Schools / Departments vide paper read (8) above as follows.
- sub Clause 4.1 of the Clause 4 ADMISSION- <u>Candidates shall be admitted for PG Programmes</u> (<u>admission year 2020-21</u>) on the basis of the Marks scored in the Qualifying Examination, by avoiding Entrance Test, which is practically not feasible to be conducted in the present scenario of COVID-19 pandemic.
- 6. After Considering the matter in detail and in exercise of the powers of the Academic Council, conferred under section II (1), Chapter III of Kannur University Act,1996 and all other enabling provisions read together with, the Vice Chancellor accorded sanction to relax the **sub Clause 4.1 of the Clause 4 Admission** in the existing Regulations of PG programmes (w.e.f.2010 admission) under Choice Based Credit Semester System in the Schools / Departments, as detailed in para (5) above, subject to reporting to the Academic Council.
