## ORDER

- 1. As per paper read (1) above, meeting of Teachers and student representatives was held on 16.07.2020 to discuss the mode of examinations for the Inter Semester students.
- 2. In continuation to the decisions taken in the meeting held on 16.07.2020, considering the difficulty in conducting conventional examinations in the present scenario of spreading COVID-19 pandemic, it was also resolved to assess the candidates on the basis of 50% IA and 50% of previous End Semester result with a chance to improve, when the conditions normalize and as per the paper read (2) above, the Vice Chancellor ordered to fix the modalities for the same.
- 3. As per paper read (3) above, the matter of assessment of students was communicated to the Controller of Examinations for compliance. Where as,the Examination branch vide paper read (4) requested necessary amendments of the pass conditions in the respective Regulations governing the programmes concerned and other details.
- 4. After considering the matter in detail, the Vice-Chancellor ordered to constitute an Expert committee with following members, to fix the Modalities for assessment of students in the backdrop of COVID-19 pandemic situation, as the conventional examinations cannot be conducted.
