2. As per paper read (2) above, the Scheme, Syllabus and model Question Paper of the Afzal UI Ulama (Preliminary) course for candidates both Regular course and that of School of Distance Education, was implemented.

Since Private Registration was commenced in Afzal UI Ulama (Preliminary) course, the Chairperson, BoS in Arabic (UG) was entrusted with modifying the existing Regulations, Syllabus, Scheme of the Afzal UI Ulama (Preliminary) course, for implementation to the Private Registration candidates also, vide paper read (3) above.

The Vice Chancellor, after considering the matter in detail, and in exercise of the powers of the Academic Council conferred under section 11(1) Chapter III of the Kannur University Act 1996, accorded sanction to implement the Regulations, Scheme, Syllabus and Model Question papers of the Afzal UI Ulama (Preliminary) course under Private Registration (2020), subject to reporting to the Academic Council.
