- 1. As per the read(1) above, the rates of remuneration for the conduct of examinations for School of Distance Education at School/College centres were enhanced with effect from 01/04/2017.
- 2. As per the read(2) above, the rates of remuneration for the conduct of examinations for School of Distance Education at School/College centres were enhanced with effect from 06/07/2020 for April 2020 session in view of present COVID-19 situation.
- 3. As per the paper read(3) above, all the Principals of Affiliated Colleges and Head of the Departments/Assistant Directors/Course Directors of University Departments/Centres were informed to ensure the invigilator-student ratio at the examinations should be 1:20, considering the present Covid 19 situation.
- 4. As per the paper read (4) above, The Principal, S U M College of Teacher Education requested to sanction Additional invigilator for Quarantine hall on each day.
- 5. As per the paper read (5) above, the Principal, Kannur Salafi B.Ed College informed that they had engaged one invigilator each for quarantine nall and for another student from containment Zone as per the direction from Health Workers. He requested to sanction an Additional invigilator for Quarantine hall and for a student from containment zone/hotspot on each day.
- 6. After having examined the matter in detail, the Controller of Examinations has accorded sanction to incorporate the following points in the UO referred (2) for the conduct of examinations for School of Distance Education at School/College centres with effect from 06/07/2020 for April 2020 session in view of present COVID-19 situation
 - i) The invigilator-student ratio shall be 1:20 in all centres .
- ii) The clause 'Fraction of more than five students for appointing an additional invigilator' is deleted.
 - iii) Additional invigilator shall be engaged for each Quarantine hall.
- iv) Additional invigilator shall be engaged for each student from containment zone/hotspot.

7.The U.O read(2) above stands modified/addended to this extent for April 2020 session only in view of present COVID-19 situation.
