## ORDER

- Sri Sanumon P, a candidate admitted to B Com degree programme under School of Distance Education with Enrolment No: PP16BS0337 has as per the request read as (1) above applied for his change of name in the University records as Sanoop.P on the basis of the copy of Gazette Notifications read as (2) and (3) above, and his name change was approved with effect from 02/01/2018 and communicated vide UO Note read as (5) above.
- The examination branch has, vide the UO Note read as (6) above, informed that name correction may be effected as per the rules for change in name implemented vide UO's read as (7) and (8) above.
- Since the request of Sanumon.P was received before the coming into force of the above UO's, 3. the matter was placed before the Syndicate for consideration in the light of Clause 3 (b) of rules of change in name as per which when a candidate applies for correction or change in name in University records during the middle of the course of study but before the publication of results of final year/ semester results, on the basis of correction or change in the name effected through Gazette Notification but without effecting correction or change in the qualifying certificate, such correction or change may be effected in all the records and certificates of the course of study from the beginning of admission to the course of study concerned"
- The Syndicate at the meeting held on 27/01/2022 vide item No. 2022.049 considered the matter 4. and resolved to grant permission to effect name change.

After considering the application of Sanumon.P, and in the light of the above Syndicate resolution, the Registrar has accorded sanction for changing the name of Sanumon.P, who was admitted to B Com programme under School of Distance Education with Enrolment No: PP16BS0337, as 'Sanoop.P' in the University records, as per Clause 3(b) of rules for the correction/change in name vide UOs read on 7 & 8 above, as per the name change effected in the Gazette Notification read as (2) and (3) above.
- 6. The above name change shall have effect from the beginning of admission to B Com degree programme of Sanumon.P under School of Distance Education, for the purpose of issuing Grade Cards and Certificates.
