

Sports Quota Reservation – UG/PG Courses in the Affiliated Arts & Science Colleges and University Teaching Departments ---Approved and Implemented with effect from 2014 admission onwards –Orders issued.

- 5. Minutes of the meeting of the Committee constituted to decide the matter of reservation of seats under sports quota dated 28/05/2014.

ORDER

- 1. As per paper 1st read above, one seat in each Degree course will be reserved for a candidate with outstanding records in Sports and games. One seat in a college may be given to an outstanding Sportsperson for all Post Graduate Courses put together over and above the sanctioned strength.
- 2. As per paper 2nd read above, one additional seat is reserved for accommodating an outstanding candidate for P.G. courses in University Departments.
- 3. As per paper 3rd read above Physical Education teachers of this University has submitted a representation to sanction two reserved seats for the sports persons in a subject in the graduate level courses.
- 4. The matter was placed before the Syndicate as ordered by the Vice Chancellor. The Syndicate as per paper 4th read above resolved to constitute a Committee to submit a report on the matter.
- 5. The Committee, as per paper 5th read above submitted the report on 28.05.2014. The report was approved by the Vice Chancellor.
- 6. After Considering the matter in detail, sanction has been accorded by the Vice Chancellor to issue the following orders.

For UG Courses - Affiliated Colleges

i. Two seats in each U.G. Programme will be reserved for candidates with outstanding records in sports and games, as per the eligibility norms attached. The seats will be allotted within the sanctioned strength. If eligible sports persons are not available the seats should be filled from the general merit.

For PG Courses - Affiliated Colleges

ii. One seat for every 20 seats will be reserved for outstanding sports persons for PG course in affiliated colleges. Where the number of seats is less than 20 for a subject, the seats in all the PG courses shall be pooled together and one seat for every 20 seats will be reserved as sports quota seat, limited to one seat in each course.

A minimum of one seat will be reserved for PG course in a College, if the total PG seats are less than 20.

The Sports quota seats for PG courses will be given over and above the sanctioned strength of the course.

The minimum eligibility for sports quota admission shall be representing the University from Kerala state in All India Inter University competition including Zonal Inter University Championships.

For PG Courses - University Departments

iii. One seat is reserved under each faculty in the University Teaching departments for Sports persons with outstanding achievements and the seats shall be allotted over and above the sanctioned strength.

For B.Ed course one seat is reserved under sports quota in each University centre and eligibility criteria will be as that of PG course.

- 7. The norms fixed for admission to UG/PG courses under sports quota is appended.
- 8. U.O. read (1) & (2) above revised to this extent.
- 9. This rule is applicable w.e.f. 2014 admission onwards.
- 10. Orders are issued accordingly.
