ORDER

- 1. The "Kannur University Minimum Standards and Procedure for the Award of Ph.D Degree Regulation, 2018" was implemented in the University vide paper read(1) above. As per clause 9 of the said Regulation it is stated that," There shall be a Research Advisory Committee or an equivalent body for similar purpose as defined in the Statutes/Ordinances of the university for each Ph.D Scholar``.
- 2. Dr. Hari Kurup .K.K, Asst. Professor and Head, PG Dept. Of Studies and Research in Economics, Govt. College, Kasaragod intimated vide paper read (2) that the Research Advisory committee constituted in respect of the four Research Scholars at the centre were held during the months of September and October 2019 and requested to sanction permissible allowances and TA and DA to the External Experts of the committee.
- 3. Since In future ,Research Advisory Committee is to be constituted in the case of each and every Ph.D Scholar being granted registration as per the 2018 Regulation, and as per the regulation a research scholar shall appear before the Research Advisory Committee once in six months to make a presentation of the progress of his/her research work for evaluation and further guidance, the Vice Chancellor Ordered to place the matter before the Syndicate.
- 4. Accordingly the matter was placed before the Syndicate. The Syndicate of the University, vide paper read (3) above resolved to approve the proposal regarding granting of permissible allowances including TA and DA to External Experts in the Research Advisory Committee.

- 5. The following orders are therefore issued in the matter on implementing the resolution of the Syndicate by the Director, Research Directorate, as per the power vested on him vide paper read(4).
- (i).External Experts attending the meeting of the Research Advisory Committee of Research Scholars shall be eligible for permissible allowances ,including TA and DA admissible as per rules.
- (ii). Expenditure of the above will be met from the Head of Account Part I Non Plan MH 1 301
 - 022 TA to University Authorities / Inspection Commissions.
