1. As per the paper read 1st above, Smt. Bindya.K has submitted an application for equivalence certificate for the M.Sc Applied Plant Science Degree (Regular) of University of Madras, Tamilnadu as equivalent to M.Sc Botany Degree of Kannur University with scheme and syllabus attested by the Registrar.
2. As per the paper read 2nd above, the meeting of BoS in Botany(PG) held on 14/06/2016 recommended not to grant equivalence to M.Sc Applied Plant Science Degree (Regular) of University of Madras, Tamilnadu as equivalent to M.Sc Botany Degree of Kannur University and the 41st Equivalence Committee meeting held on 18/07/16 resolved to refer back the matter to the Board of Studies for reconsideration.
3. As per the paper 3rd above, the meeting of BoS in Botany(PG) held on 07/01/2017 recommended not to grant equivalence to M.Sc Applied Plant Science Degree (Regular) of University of Madras, Tamilnadu as equivalent to M.Sc Botany Degree of Kannur University and the 42nd Equivalence Committee meeting held on 20/05/17 resolved to accept the recommendation of BoS and decided not to recognize M.Sc Applied Plant Science Degree (Regular) of University of Madras, Tamilnadu as equivalent to M.Sc Botany Degree of Kannur University.
4. As per the paper read 4th above, Smt. Bindya.K again submitted a request to issue equivalence certificate for M.Sc Applied Plant Science Degree (Regular) of University of Madras, Tamilnadu as equivalent to M.Sc Botany Degree of Kannur University for getting her SET certificate and for employment purpose.

5. Considering the matter in detail, the Hon'ble Vice Chancellor has ordered to place the matter before the Syndicate. As per the paper read 5th above, the Syndicate meeting held on 13/04/2018 resolved to authorize the Vice Chancellor to take appropriate action in the absence of the Academic Council.
6. After considering the matter in detail, the Hon'ble Vice Chancellor exercising the powers of the Academic Council, has ordered to recognize M.Sc Applied Plant Science Degree (Regular) of University of Madras, Tamilnadu as equivalent to M.Sc Botany Degree of Kannur University for all purpose, subject to reporting to the Academic Council.
