ORDER

- 1. In the Regulations for B.Tech Degree Courses we f 2007 admission- implemented vide paper read (1) above, the Sub clause (v) of clause 11 of the regulation-Procedure for completion of the course, states that "A candidate should complete the programme and pass all Examinations within seven (7) years. (six years in case of L.E.S) Since his/her admission to B.Tech Programme.
- 2. As per paper read (2) above, Re-registration fee for B.Tech course was enhanced to Rs.4200/-(Rupees four thousand two hundred only) and B.Tech students of 2011 admission (New scheme) were permitted to re-register for the course and appear for examination upto April/May 2019.
- 3. Meanwhile, considering representations of B.Tech students of 2010 admission requesting permission to register for supplementary examination, as they have exceeded 7 years of the course as stipulated in the Regulation, Academic D section, vide paper read (3) has requested to issue a necessary general orders in this regard.
- 4. The matter was placed before the BoS in Engineering (UG), held on 28.11.2019 and vide paper read (4) above, the Board recommended to grant one more chance to B. Tech students of 2010 admission to re-register for the course, relaxing sub clause (V) of clause 11 of B. Tech Regulation, and permitted to appear for the examination,
- 5. The Vice-Chancellor, after considering the matter in detail, and to extend the benefit to all students, in exercise of the power of the Academic council conferred under section 11(1) of Kannur University Act 1996 and all other enabling provisions read together with, issued the following orders.

"One last chance for re-registration (applicable to all semesters) for B.Tech students who have taken admission from 2007 to 2014, will be given . This special Exam will be held in the month of October 2020, press release be issued in this regard by end of January 2020. Application for the same will be called in the month of September".

6. The U.O read (1) above stands modified to this extent.

Orders are issued accordingly.
