### ORDER

1) The revised regulations for UG Programmes under Choice Based Credit Semester System were implemented in the University w.e.f. 2009 Admission as per the paper read (1) above and certain modifications were effected to the same vide paper read (2), (3) & (4).

2) The Academic Council at its meeting held on 04-02-2013, considered the request of the exam branch to modify the improvement condition for Under Graduate Programmes and resolved vide paper read (6) above to revise the improvement conditions of UG Programmes under Choice Based Credit Semester System from 2011 admission onwards so that the improvement benefit can be enjoyed in the first subsequent chance alone.

3) The Vice Chancellor after considering the matter in detail has accorded sanction to incorporate the above recommendations of the Academic Council in the Regulations for Under Graduate Programmes under Choice Based Credit Semester System with effect from 2011 admission.

4) Orders are therefore issued modifying **Sub Clause -4 of Clause- 8 -'Improvement '-** in the Regulations for Under Graduate Programmes under Choice Based Credit Semester System as detailed at para-2 with effect from 2011 admission.

After amendment, Sub Clause -4 of Clause- 8-'Improvement '-in the Regulations for Under Graduate Programmes under Choice Based Credit Semester System reads as follows :

8.4 Improvement: A student who secures a grade other than E in a Course in a subject is permitted to register within 14 days after the declaration of results for re-examination, for improving the performance if she/he desires so, and can appear for the re-examination in the subsequent chance. The student need not attend classes again to appear for re-examination. The Internal Grade already obtained will be carried forward to determine the new grade in the re-examination. If the candidate fails to appear for the improvement examination after registration, or if there is no change/ upgradation in the grade after availing the improvement chance, the grade obtained in the first appearance will be retained. There shall be no improvement chance for the grade obtained for Internal Evaluation. There shall not be more than one improvement chance for a course.

5) The U.Os read above stand modified to this extent.


