ORDER

- 1. Clause **6.2** of the Regulations for Under Graduate Curriculum (Choice Based Credit Semester System) in Affiliated Colleges implemented w.e.f 2014 admissions (paper read 1 above) states that "A student who registered for a UG Programme shall successfully complete the programme within 6 years from the year of first registration. If not, such candidate has to cancel the existing registration and join afresh as a new candidate".
- 2. The XXVIth Academic Council vide item No.1(4) accepted the recommendations of the Examination Branch with respect to Mercy Chance examination and resolved to grant permission to conduct mercy chance examinations to the Under Graduate (2014 regulations) candidates of Affiliated Colleges who have already crossed the maximum period for the completion of the programmes.
- 3. The Examination Branch vide paper read 3 above requested to make necessary modification in the Regulations concerned and to fix re-registration fee for the Mercy chance examination.
- 4. Considering the matter, the Vice Chancellor has ordered to place the matter of fixing the reregistration fee as well as course wise fee to be levied from the applicants for Mercy Chance Examinations before the Syndicate for consideration,
- 5. The syndicate held on 19.10.2023, vide item No. 2023.482 (Paper read 4) considered the matter and resolved to fix the re-registration fee as ₹4000/- and Course wise Examination fee as ₹1000/- from the applicants for Mercy chance examination..
- 6. The Resolution of the syndicate has been implemented. In view of the resolutions of the Academic Council and resolutions of the syndicate implemented in the University, relaxation has been effected to Clause 6.2 of the Regulations for Under Graduate Curriculum (CBCSS) 2014 in accordance with the decision of the Academic Council and Syndicate to conduct One Time Mercy Chance Examinations to the Under Graduate (2014 Regulation) candidates in affiliated colleges who have already crossed the maximum period for the completion of the programme, levying the fee rate as fixed as mentioned above.

- 7. The Examination Branch shall take further action for the conduct of mercy chance examinations levying the fee rate as fixed as mentioned above.
- 8. Orders are issued accordingly.
